Bridgewater	N/A	No	15-Apr-20	No decision yet. Information will be available as updates are made.

Colchester County	N/A	No	15-Apr-20	Annual tax bills are mailed each June, and payment is due in August; no change to these procedures.

Digby	N/A	No	16-Apr-20	Interim tax bills will not be sent in April. Will continue to provide updates as decisions are made.
East Hants	N/A	No	15-Apr-20	Currently in conversations with NSFM & the Province, but no deferral plan currently in place.
Guysborough County	N/A	Yes	15-Apr-20	Interest on property tax bills waived until August 31st
Halifax Regional Municipality	N/A	Yes	15-Apr-20	Interim tax bill payment deferred to June 1st (from April 30th).
Inverness County	N/A	No	15-Apr-20	Waived Interest for March, April & May on tax and water bills. Tax bills are scheduled to be sent out in June, with 90 days to pay. Water bill payment deadline has been extended to 60 days (from 30). Payment plans are available to residents on a case-by-case basis.
Kings County (including New Minas; Kentville; Kingston; Berwick; Wolfville)	N/A	Yes	15-Apr-20	Interim tax bill payment deferred to July 31st (from May 31st). Interest suspended on tax and water levies until July 31st.
Lunenburg	N/A	Yes	15-Apr-20	The interim tax bill payment deadline will be extended to August 31, 2020 (from May 31). The interim tax bills will be mailed at the end of April; however, no interest will be applied until September 1, 2020.
Municipality of the County of Queens (including Liverpool)	N/A	Yes	15-Apr-20	Interest forgiveness on tax bills, including water and sewage charges, has been extended extended until July 31
New Glasgow	N/A	No	15-Apr-20	No deferral plan in place, but residents will be allowed flexibility on payment, on a case by case basis. Monthly interest on arrears has not been updated for March, nor will be for April.
Pictou	N/A	No	15-Apr-20	No deferral decisions made as of yet. Bills being sent in May (instead of April). Council looking at all options, and waiting for directive from the Province. Quarterly water bills have been given a 60 day payment deadline (instead of 30).
Port Hawkesbury	N/A	Yes	15-Apr-20	Interest payments for the months of March & April have been deferred until the end of May. Continually monitoring the situation with more information coming soon.
Shelburne County	N/A	No	16-Apr-20	Annual tax bills are typically due June 30th, but the payment deadline will be pushed until at least July 30th. Interest waived on accounts until further notice. More information is to be available by end of April.
Truro	N/A	No	15-Apr-20	Annual tax bills have not yet been mailed, but payment is usually due in June. There have not been any changes made to these procedures yet.
Victoria County	N/A	No	16-Apr-20	Interim tax deferral plans have not been made yet. Annual bills are typically sent in June. More updates may be available closer to that time.
Windsor-West Hants	N/A	No	16-Apr-20	Annual tax bills will be sent in July. County is in the process of identifying a relief plan, should one be required at that time.

Charlottetown	Yes	Yes	15-Apr-20	Until further notice, there will be no interest charges on late payments for municipal services, such as water and sewer. No disconnections as a result of non-payment will occur at this time.
Summerside	Yes	Yes	15-Apr-20	Until further notice, there will be no interest charges on late payments for municipal services, such as water and sewer. No disconnections as a result of non-payment will occur at this time.
Kensington	Yes	Yes	15-Apr-20	Interest charges on water and sewer bills will not be collected until September 30, 2020
